The results of investigation of various features of the subjective perception of sources of danger by the population living in Volzhsky and Volgograd are represented. As a result of the public opinion poll a statistically significant difference in the perception of some hazards by the respondents of the two cities was revealed. In addition, in Volzhsky and Volgograd significant differences in the subjective perception of the hazards of men and women, as well as the respondents of different age groups were identified.
