The article considers the relationship and interaction of a number of sociological concepts related to the study of protest activity in society. The author analyzes the conceptual content of the approach to the study of social protest worked out by T. Gurr, as well as methodological adaptation of the approach, made relevant by contemporary social and political trends. Using this approach, the author offers an original concept to explore the potential of protest social activity, which is based on four factors: groups a) the dysfunctional social conditions, b) the type of civic culture, c) organization and mobilization factor and d) institutional factor.

This article analyzes the functioning of political trust networks in the political system of Russian society. As it is noted in the article, the political trust network follows the tradition of organizing by «clannishness» principle as in the Soviet period and fixed at the level of political team creating practice in the post-Soviet period. The author substantiates the independent position of the political trust networks based on the positive stabilizing role of political trust networks in the context of a high level of institutional distrust in the political system. For the author of the article it is obvious that the compensating attention of political trust networks narrows the possibilities for institutional restructuring of the political system and in this regard, it becomes important to include these networks in the integration mode with government and civil-political structures.
